For over 48 years, we have been steadfast in our mission to protect the rights and entitlements of individuals with disabilities, chronic health conditions, and the frail elderly. 





# COMMUNITY HEALTH LAW PROJECT

#### **Examples of Success Stories**

#### **8 Year Old Girl Receives New Medical Equipment**

A dedicated staff attorney at the CHLP's Neptune office recently significantly impacted the life of an 8-year-old girl. This young client was diagnosed with a rare congenital disorder requiring constant care and specialized medical equipment to support her daily activities. However, when she outgrew her equipment, her insurance company refused to cover the new, size-appropriate gear she needed. Undeterred, our attorney took action. He filed an appeal and represented the girl in an administrative hearing, fighting tirelessly on her behalf. Thanks to these efforts, the insurance company's decision was overturned, and the girl received the essential medical equipment she needed.

#### **Woman Takes Over Her Deceased Mother's Lease**

Our Bloomfield office recently helped an Essex County resident facing a difficult situation after her mother passed away without a will. Since she wasn't on the lease, she was worried the landlord would make her leave.

Additionally, the security deposit was still in her mother's name.

Our attorney stepped in and the client was appointed as the legal administrator of her mother's estate, allowing her to negotiate with the landlord.

Thanks to these efforts, the landlord allowed her to stay and transferred the security deposit to her name.

#### **Visually Impaired Man Becomes a Poll Worker**

CHLP's Westmont office recently helped a client who faced job discrimination due to his visual impairment. Our client, who receives services from the Commission for the Blind and Visually Impaired, was turned down by the County Board of Elections (BOE) to serve as a poll worker, despite meeting all the state requirements. CHLP staff did extensive research and found that the BOE had violated the New Jersey Law Against Discrimination by rejecting him without offering reasonable accommodations. We explained this law to the BOE, leading them to reverse their decision. They invited our client to a poll worker training session and provided information on the available accommodations.

This outcome was a significant victory for our client, ensuring his right to work without discrimination.

#### **New Grants & Programs**

#### NJ Bar Foundation Co-Sponsorship Award Legal Assistance and Education to Promote Housing Stability

CHLP received a New Jersey State Bar Foundation (NJSBF) cosponsorship grant to provide direct legal services to tenants with disabilities throughout the State. Legal assistance will include advice and representation for residents with housing-related issues such as substantial rent increases, habitability concerns, housing subsidy issues, housing discrimination, and other issues that affect housing stability.

#### **DCA Comprehensive Eviction Defense and Diversion Program**

CHLP received funding from the Department of Community Affairs (DCA) to continue the Comprehensive Eviction Defense and Diversion (CEDD) Program statewide. Launched in January 2023, the CEDD program helps low-income renters facing eviction due to rising housing costs and the end of pandemic-era tenant protections. The program offers free housing support, financial aid, and legal services. CHLP will serve as a legal assistance provider in all 15 court vicinages across the state.

#### **Senior Save Navigator Program**

CHLP received funding from the NJ Division on Aging Services to help low-income seniors and individuals with disabilities in Atlantic County apply for the NJSave program. NJSave is an application that helps low-income seniors and individuals with disabilities save money on Medicare premiums, prescription costs, and other living expenses. CHLP navigators will reach out to the community, assist with gathering necessary documents, complete applications, and follow up with the state to determine eligibility.
